How to mail a security certificate:

If you are sending an actual security certificate, include an original letter, signed by you or your broker, giving Good Shepherd Sustainable Learning Foundation permission to transfer the ownership of the certificates.

Be sure to sign each certificate exactly as it appears on the document. Make sure to have a Signature Guarantee to endorse the transfer by asking your bank to stamp a medallion signature certification ensuring the authenticity of your signature.

The certificate(s) must be accompanied by a stock power letter (one for each certificate) giving Good Shepherd Sustainable Learning Foundation ownership of the certificate. Make copies of the original letter(s) giving Good Shepherd Sustainable Learning Foundation permission to transfer the certificate, along with the certificate and stock power letter for your own files.

Next, mail the actual certificate(s) along with the stock power letter(s) and the original letter(s) to the address below. Please use a mailing service that provides tracking numbers.
